Tom Cullum opposed. Approved. Connie Weinzapfel made the motion to authorize Adam Green to reach out to Tri-State painting to coordinate a final bid for the roof restoration. Tom Cullum seconded. Approved

Minutes of the August 19, 2021 meeting had been sent electronically. Connie Weinzapfel moved to accept the minutes. Nathan Maudlin seconded. Accepted.

Connie Weinzapfel then presented the Treasurer's Report. Nathan Maudlin moved to accept and hold for audit. Tom Cullum seconded. Approved.

Nathan Maudlin made the motion to move \$175,000 from our actively managaed accounts and place it in our Roof Restoration Fund with the intent of replacicing it with other fundraiser proceeds. Tamara Allison seconded. Approved.
